## NEW TORY MPPS

In the 2018 Ontario general election, the PCs won 76 seats in the province's 124 seat legislature and formed a majority government. In the period between that election and the one on June 2, 2022, two PC MPPs resigned as MPPs (Yurek and Phillips), three resigned from the PC caucus of their own accord to become Independents (Wilson, Park, Simard; Simard subsequently joined the Liberals) and four were banished from the PC caucus (Hillier, Karahalios, Baber and Nichols). At time of dissolution, the Tories held 67 seats.

In the June 2, 2022 Ontario general election 28 brand new MPPs were elected to serve on the PC Government benches. Some won in ridings where the incumbent PC MPP did not seek re-election (HOLD). Some won in ridings that in the 2018 general election were won by PC candidates who subsequently changed their allegiances to either Independent or to another party (HOLD/GAIN). And still others defeated incumbent MPPs from other parties (GAIN) or won in ridings where the previous MPPs from other parties did not seek re-election. Here's the list;

Ford defeated incumbent former NDP MPP Faisal Hassan

As a post script, there are only two ridings that were represented by PC MPPs in the last provincial parliament where a PC was not elected in June 2022.

## PUBLICATION OF MANDATE LETTERS ACT, 2022 WOULD MAKE PUBLICATION OF MINISTERS MANDATE LETTERS MANDATORY

On August 22nd, the Liberal MPP for Don Valley East, Adil Shamji, introduced Bill 10, Publication of Mandate Letters Act, 2022. According to the Explanatory Note accompanying the text of the Bill:

*“The Bill amends the Executive Council Act and the Freedom of Information and Protection of Privacy Act.*

*The Executive Council Act is amended to include a new section 2.1, which requires that the Premier publish mandate letters, as defined in subsection (1) of the new section.*

*Section 12 of the Freedom of Information and Protection of Privacy Act, which provides an exemption to the disclosure of records under that Act where the disclosure would reveal the substance of deliberations of the Executive Council or its committees, is amended to provide that a head may*

*not refuse to disclose a mandate letter under that section, even where its disclosure would reveal such deliberations.”*

In their mandate letters to ministers, premiers articulate their priorities and performance expectations for each minister, what initiatives the minister is to undertake and the outcomes to be achieved. Publishing these mandate letters is the mark of a government that is confident in its vision and its ability to get things done and a government that operates in an open and transparent way and is willing to be held accountable by the public. Publishing mandate letters is a long-standing tradition of previous governments that unfortunately Premier Ford has chosen not to follow.

Bill 10 has little chance of seeing the light of day.

## GOVERNMENT FAST TRACKS BILLS – LEGISLATURE COULD ADJOURN EARLY

By way of a time allocation motion, the government has put time limitations on the debates for its two top priorities, Bill 2, Plan to Build Act (Budget Measures) 2022 and Bill 7, More Beds, Better Care Act and has fast tracked the two pieces of legislation to go directly to Third Reading after Second Reading, bypassing the usual committee hearings and clause-by-clause examination process. It's expected that the two Bills could pass Third Reading as early as Thursday, September 2nd.

Some have speculated that if all goes according to plan, another government priority, Bill 3, Strong Mayors, Building Homes Act, 2022, will make its way through the committee process and be up for Third Reading vote on Thursday, September 2nd and that if all of the above occurs, the legislature could adjourn that day for a late summer break.

## MORE FORMER ONTARIO MPPS SEEKING MUNICIPAL OFFICE

In case you missed it, the former Liberal MPP for Vaughan (2012 – 2018), Wynne era Transportation and Economic Development Minister (2014 – 2018) and former Leader of the Liberal Party of Ontario (2020 – 2022), Steven Del Duca, is campaigning to be mayor of Vaughan. The incumbent, Maurizio Bevilacqua, is not seeking re-election. Del Duca is facing off against Parveen Bola who is a nurse, entrepreneur Danny DeSantis, real estate broker Robert Gulassarian, school principal Lino Mancinella and sitting city councillor Sandra Yeung Racco.

And former NDP MPP for Hamilton Centre (2004 – 2022), former ONDP Leader (2009 – 2022) and former Leader of the Official Opposition in the Legislative Assembly of Ontario (2018 – 2022) Andrea Horwath has thrown her hat in the ring” to become the next mayor of Hamilton. Incumbent Mayor Fred Eisenberger is not seeking re-election. Horwath who has the endorsement of Eisenberger, recently resigned her seat in the Ontario legislature. Also in the contest for the big chair around the horseshoe at city hall in “The Hammer” are former mayor Bob Brattina (2010 – 2014) and former chamber of commerce president Keanin Loomis.

Not seeking the shiny mayor's chain of office but running for a seat on city council in Cambridge is former PC MPP turned New Blue MPP for Cambridge, Belinda Karahalios, who was defeated in the recent Ontario general election.
